GENERAL INFORMATION REGARDING THE PROCESSING OF PERSONAL DATA

(Legislative Decree 196 of 30/6/2003)

In accordance with Article 13 of the Legislative Decree of 30 June 2003 no. 196 regarding data protection, with reference to all the information which can be defined as personal data, even supplied verbally in the past and which will be supplied in the future in relation to economic, commercial and contractual relationships, we inform you of the following points:

1. the collection or processing of personal data is only necessary in order to carry out the economic activity of our company in an appropriate way, and to fulfil administrative, legal and fiscal obligations.
2. the processing of data will take place with the greatest possible discretion, and will respect the principles of correctness, and the Legislative Decree of 30 June 2003 No. 196, both in terms of paper and electronically stored data.
3. personal data and any processing of such will not be subjected to communication or diffusion, except when required by law, and if so, this will be carried out according to the Law itself.
4. you have the authority to exercise your rights according to article 7 of the Legislative Decree no. 196/03. In particular the person concerned may obtain from the owner confirmation of the existence or non-existence of any data concerning them, and its communication in intelligible form. The person concerned can also request to be informed regarding the origins of the data, the purpose and the modality of processing, as well as the applied logic in case of processing using electronic instruments, information regarding the identifying details of the owner, any named people in charge and the subjects and categories of subjects to whom the data can be communicated, or who could become aware of it. The person concerned has the right to oppose, either entirely or partly, for legitimate reasons, the processing of personal data concerning him or her. Such rights can be exercised by means of a recorded delivery letter which contains a request to the person in charge or our company regarding the processing of data.
5. the owner of the processing of data is the company in the person of the legal representative
